Application for a renewable interment right

Purpose of this application form

This application form should be completed by a consumer that seeks to acquire a renewable interment right at a cemetery. A renewable right is a limited period right and cannot be held for longer than 99 years.

The cemetery operator will advise the consumer about the period of the initial term. The initial term must be:

- any period up to 99 years for cremated remains
- any period between 25 and 99 years for non-cremated remains.

The consumer can apply to the cemetery operator to have the right renewed after the initial term expires. Each renewal period must be a minimum of 5 years. The cemetery operator will advise the consumer about the renewal period.
